THE COUNCIL IS LOOKING AT REASSIGNMENTS OF IT'S INTERNAL COMMITTEE, LAST MEETING WAS SEPT. 21, 2011 AT UW-STOUT WHERE THE FOCUS WAS LIDAR DATA. RON WENCL GAVE AN OVERVIEW ON THE NATIONAL ENHANCED ELEVATION REPORT (NEEA) AND IS LOOKING TO GETTING A WISCONSIN INVENTORY DONE FOR THE

ELEVATION COMMITTEE. THE STATE-WIDE ORTHO BUSINESS PLAN IS GETTING STARTED. HOPE TO GET A LIDAR COMPONENT ADDED TO THE RESEARCH.
